Adoption of Budget

Motion made by Mrs. Balut, seconded by Mrs. Falcone, and approved by roll call vote (9-0), to adopt the 2019-20 School Budget Resolution as presented.

BE IT RESOLVED, that the Gibbsboro Elementary School District Board of Education approval in the grand total amount of \$5,101,800 which includes a General Fund total of \$4,773,890; a Special Revenue fund total of \$98,910; and a Debt Service Total of \$229,000; and also includes a General Fund local tax levy of \$3,010,446 and a Debt Service local tax levy of \$229,000 to be raised for the ensuing 2019-2020 school year

New Business

Motion made by Mrs. Balut, second by Mrs. Carrington, and approved by roll call vote (9-0) to adopt the following resolution and action were approved:

1. **Resolved**, to establish travel and related expense reimbursement in accordance with NJAC 6A-23A-7.3 and District Policy 6471 to a maximum expenditure of \$15,000 for all staff and board members, affirm the maximum expenditure in the 2018-19 school year was established at \$15,000, and the current 2018-19 expenditures to date for travel are \$322.00.
2. To approve Amanda Frick as a long-term substitute effective May 13, 2019 through June 30, 2019, pending due diligence.

Having no further business, on **motion** made by Mrs. Falcone, second by Mr. Alexander and unanimously approved by roll call vote (9-0), the meeting was adjourned at 7:30 pm.
